Information on current regulations

Information on how personal data is handled

Failure to provide personal data makes it impossible to obtain the requested service.

The data controller is P.A.F.O.M., with a registered office in Rocca di Papa (Rome - Italy), Via Frascati, 306.

The applicable regulations recognize a series of rights for the applicant, including, by way of example, the right to: (i) access their personal data; (ii) request its correction; (iii) request its updating and deletion, if the data is incomplete, incorrect or collected in violation of the law; (iv) request that the processing be limited to the part of the information concerning them; (v) transmit to them, or to third parties indicated by them, the information concerning them ("data portability"); (vi) oppose its processing for legitimate reasons; (vii) revoke their consent at any time by written request, addressed without formality to P.A.F.O.M., sent by e-mail to info.archiviogenerale@focolare.org.

P.A.F.O.M. reminds applicants that, where the response to requests is not considered satisfactory, the user may contact and lodge a complaint with the Guarantor Authority for the Protection of Personal Data (garanteprivacy.it) in the manner provided for by the applicable regulations.
